- fully respect confidentiality requirements in dealing with child protection matters.

The school will also adhere to the above principles in relation to any adult pupil with a special vulnerability.

- Risk of harm due to inadequate supervision of children while attending out of school activities
- Risk of harm due to inappropriate relationship/communications between child and another child or adult
- Risk of harm due to children inappropriately accessing/using computers, social media, phones and other devices while at school
- Risk of harm to children with SEN who have particular vulnerabilities
- Risk of harm to child while a child is receiving intimate care
- Risk of harm due to inadequate code of behaviour
- Risk of harm in one-to-one teaching / coaching situation
- Risk of harm caused by member of school personnel communicating with pupils in

an inappropriate manner via social media, texting, digital device or other manner

- Risk of harm caused by member of school personnel accessing/circulating inappropriate material via social media, texting, digital device or other manner
- Risk of harm caused by school personnel or another child when engaging in remote teaching and learning e.g. screenshotting images and sharing without consent, changing the images to cause hurt and embarrassment etc.
- Risk of harm being caused to child while engaging in remote teaching and learning e.g. viewing inappropriate behaviour or images.

## The school has the following procedures in place to address the risks of harm identified in this assessment:

- All school personnel are provided with a copy of the school's Child Safeguarding Statement. This is displayed in all rooms of the school, at the reception of the school and on the school website.
- The Child Protection Procedures for Primary Schools 2017 are made available to all school personnel. These are in hard copy in staffroom and in each classroom.
- School Personnel are required to adhere to the Child Protection Procedures for Primary and Post-Primary Schools 2017 and all registered teaching staff are required to adhere to the Children First Act 2015
- The school implements in full the Stay Safe Programme/ Walk Tall and anti-bullying campaign.
- The school implements in full the SPHE curriculum.
- The school has an Anti-Bullying Policy, which fully adheres to the requirements of the Department's Anti-Bullying Procedures for Primary Schools.
- The school has a yard/playground plan to ensure appropriate supervision of children during, assembly, dismissal and breaks and in respect of specific areas such as toilets etc
- The school has in place clear procedures in respect of school outings.
